Simply put; it is a collection of records about you attached to a government database containing:

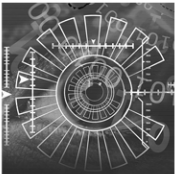
- Username ▪ Password ▪ Date of Birth ▪ Social Security/Insurance Number ▪ Medical History
- Online Search Patterns ▪ Online Purchasing Patterns ▪ Transaction History ▪ School Records
- Police Interactions ▪ Political Leanings ▪ Charitable History ▪ Credit Rating ▪ Social Credit Score

IN ORDER TO SECURE THAT INFORMATION, GOVERNMENTS WILL USE THE FOLLOWING BIOMETRIC IDENTIFIERS:



## FACIAL RECOGNITION SCAN

A fingerprint-like geometric map of your face will be used to confirm your identity. This will also be used for CCTV tracking and targeted ad placement in the real world.



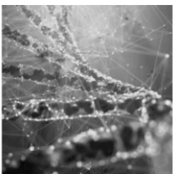
## RETINAL SCAN

A full profile of your eye will be created and used to identify you at specific access points. This, like other identifiers, can be used to identify you before allowing you internet access.



## THUMB SCAN

Your thumb and / or fingerprints may also be used to confirm your identity. You may be denied entry to government buildings or businesses without authentication.



## GENETIC SCAN

As technology progresses, this method of identity authentication will become more popular. Your Genetic Profile will be tested on-site to confirm your identity.

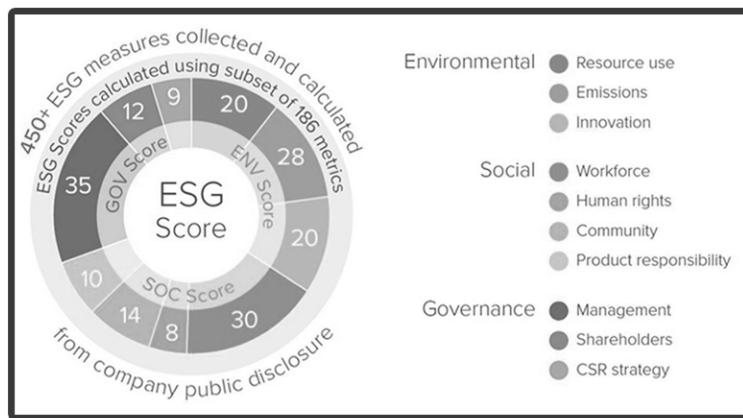
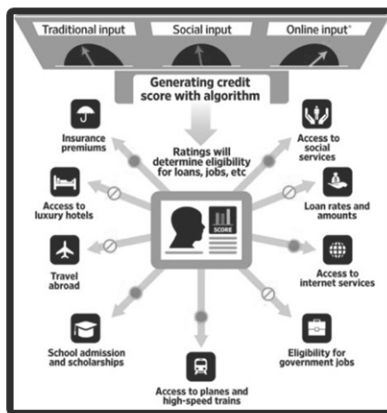
# WHAT IS SOCIAL CREDIT AND AN “ESG SCORE”?

The data compiled in your digital ID will be rated and scored based on if your behavior and opinions are in alignment with government policy and agenda. The more out of alignment you are with what is defined as a “good citizen,” the more difficult it will be for you to access government services, enjoy privileges, transact, earn a living, or shop at specific businesses.

If your score goes low enough, you will be blacklisted and completely shut out of society.

An “ESG Score” is the business version of social credit.

Environmental, Social, and Governance metrics will be used to determine if a company’s product, operations, messaging, and ideologies are in alignment with sustainable development / equity policies. Businesses with very low scores will be unable to use transaction systems, get loans, or even renew a license, and customers who support those businesses will have their social credit scores lowered also.



This system will be attached to your digital ID, which you will be forced to biometric authenticate with. You will be unable to do anything without your identity attached, and everything you do will be used to adjust your level of freedom and access to society or the goods and services you need. It will be sold to you as beneficial. A “safe and secure way to verify your identity online.”

In fact, it will completely remove your right to privacy, enable cashless society, and bring about a world where simply disagreeing with your own government could remove you of your right to survive at all.

Public - Private Partnerships are governments and businesses working together to fundamentally change your life forever. You are not being properly informed of the negative uses for this technology, your consent is not being sought. This technology is being installed as you read this and will soon control every aspect of your existence.

You may agree and behave in alignment with the government definition of a “good citizen” today, but have you always? Will you tomorrow?
